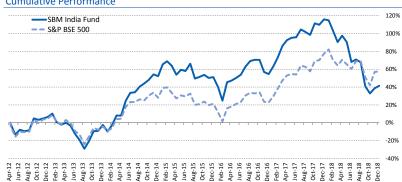

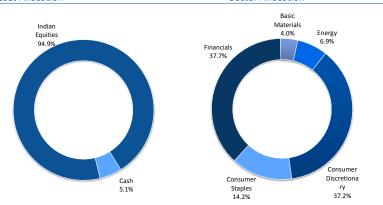

Fund Manager Commentary

The Fund gained 2.0% during the month against 0.5% for S&P BSE 500, in USD terms. Indian equities delivered mixed returns on the back of monetary tightening in the US weak global cues and cautious sentiment ahead of general elections in 2019.

Sector-wise, the BSE Public Sector Undertakings was the top performer (5.9%) during the month followed by BSE India Infrastructure (5.0%) and BSE Power (4.7%). On the other hand, BSE Healthcare returned -2.8% while the BSE Information Technology and BSE Teck posted -1.4%. Year-on-year, the BSE Information Technology was the best performing sector with a USD return of 14.5%.

In December, the manufacturing Purchasing Managers' Index (PMI) fell to 53.2 compared to the preceding reading of 54.0 an account of slower growth in new orders and lower output. As at November 2018, fiscal represented 114% of the budgeted estimates for fiscal year 2019. GDP growth slowed down to 7.1% year-on-year in Q2FY19, after four consecutive quarters of acceleration, weighed down by moderation in private consumption and a large drag from net exports.

At policy level, the Reserve Bank of India (RBI) kept the policy repo rate under the liquidity adjustment facility (LAF) unchanged at 6.5% during the Monetary Policy Committee (MPC) meeting held in December. The reverse repo rate under the LAF remained at 6.25% and the marginal standing facility (MSF) rate and the Bank Rate at 6.75%. The decision of the MPC is consistent with the neutral stance of monetary policy in consonance with the objective of achieving the medium-term target for consumer price index (CPI) inflation of 4% while supporting growth.
