Reporting to the Manager – Regulatory Reporting, the job incumbent will be mainly responsible for the preparation of regulatory reports for the Bank while ensuring adherence to Bank of Mauritius (BOM) guidelines and in line with BOM taxonomy.

Key Responsibilities:

- Prepare regulatory reports (XBRL/RBS) on a monthly, quarterly and yearly basis while in conformity with BOM guidelines and the XBRL Taxonomy
- Perform daily Trial balance monitoring while analysing the daily movement of General Ledger accounts
- Perform reporting of daily Trial balance to Management and respond to their queries
- Assist internal auditors and external auditors in audit of Regulatory reports
- Respond to queries from regulators
- Review less complex regulatory reports to be filed with the BOM
- File surveys and questionnaires with relevant authorities on a quarterly/half yearly/yearly basis
- Ensure high level of service standards, including high level of ethics and integrity in line with SBM values
- Perform any other cognate duties as and when required
