- This SBM Visa Card Usage Campaign is valid for the period starting from 01st February 2026 to 15th April 2026 inclusive. (the "Campaign Period")
- The Campaign will be run over a period of 2.5 months and the prizes include two packages with 4 Match tickets for Final of the FIFA World Cup 2026™ in USA and includes the following:
 - 4 nights 4* accommodation, including breakfast
 - Visa Pre-paid card: \$600
 - Daily breakfast * light snacks available at hotel

- The Campaign is open to all SBM Visa Debit and Credit cardholders (except SBM Visa business cardholders).

 - 2 entry tickets for every Rs 500 spent for online and international purchases, calculated on a cumulative basis

 - Visa Infinite Credit Card

- SBM Staff cardholders are eligible for the Campaign.
