1. Introduction

SBM Bank (Mauritius) Ltd invites Expressions of Interest (EOI) from qualified contractors for the purpose of **prequalification**. The Bank intends to establish a shortlist of eligible service providers who may be invited to participate in subsequent **Request for Quotes (RFQ) / tender exercises**.

2. Objective of the EOI

The objective of this EOI is to identify and prequalify competent contractors for the renovation of SBM La Ferme and Mont Lubin branches as well as other works of similar nature. Shortlisted applicants will subsequently be invited to participate in a formal tender process, where detailed scopes of services, terms of reference, and commercial requirements will be provided. Interested firms must demonstrate proven experience, technical expertise, and relevant professional certifications in their respective fields. The objectives are as follows:

3. Service Categories

The Bank seeks to prequalify firms in the following categories:

- Building & Civil Works
 - Demolition and carting away, fit out, partitioning works, concrete works, plastering & painting etc..
- Metal Works
 - Welding works, galvanized structures etc..
- Signage Works
 - Illuminated signages and graphics.
- Mechanical, Electrical & Plumbing
 - Supply & Installation of sanitary wares and other plumbing related accessories.
 - All electrical works in a building and civil environment.
- Supply and installation of furniture items
 - Supply & Manufacture of workstations, cupboard, drawers, kitchen cabinets, etc...
- Supply and installation of internal doors, aluminium openings, and roller shutters.

Note:

This EOI does not include detailed scopes of services.

Detailed Terms of Reference (TOR), deliverables, and project-specific requirements will be issued at the tender stage **to shortlisted firms only**.

4. Eligibility Criteria

General Requirements

- Legally registered entity
- Valid business license (CIA registered where applicable)
- Minimum five (5) years of relevant experience
- Ability to operate in Rodrigues within deadlines

- Demonstrated experience in similar assignments

5. Submission Requirements

Interested Contractors shall submit:

1. Description of the business, including company profile, copy of certificate of incorporation, BRN & VAT certificate, CIA/CIDB registration certificates, where applicable
2. Relevant experience and client portfolio for the last 5 years
3. Financial statements for the past 2 years
4. Clearly indicate **service category(ies)** applied for
5. Annex 1 duly filled.

6. Evaluation and Shortlisting

Submissions will be evaluated based on:

- Experience and past performance
- Technical capacity
- Qualifications of personnel
- Financial capability
- Completeness of submission

Only **pre-qualified and shortlisted firms** will be invited to participate in subsequent **tender/RFQ processes**.

7. Subsequent Tender Process

Shortlisted firms will receive:

- Detailed Scope of Services / Terms of Reference
- Technical and financial proposal requirements
- Evaluation criteria
- Contract conditions

Participation in the EOI **does not guarantee** an invitation to tender.

8. Duration of Prequalification

The prequalification list may remain valid for **5 years**, subject to periodic review.

9. Important Notes

- This EOI is **not a tender** and does not constitute a commitment to award any contract
- The Bank reserves the right to:
 - Reject any or all submissions
 - Request additional information
 - Amend or cancel the process
